Patty reviewed the summary of the lease purchase agreement (LPA), terms and conditions, sources of funds, and Resolution No. 002-2022 with the board and took questions from the board.

Ed Gonzalez, the president of the governing council, read the following statement:

"This is a meeting of The Montessori Elementary and Middle School's Governing Council for the purpose of considering the acquisition of its current site; 8.64 acres of land and a 34,785 sq foot facility located at 1730 Montaño Road, NW, Albuquerque, NM 87107 from CSDCPC TMS, LLC. ("CSDC"), through a lease purchase arrangement as defined by the New Mexico Public Schools Lease Purchase Act. You have been provided a Summary of the Lease Purchase Arrangement Terms and Conditions, a copy of the Lease Purchase Arrangement with exhibits prepared by our attorney, as well as a document titled "Source of Funds for Facility Payments Pursuant to the

Lease Arrangement," and a copy of the proposed Resolution concerning the Lease Purchase Arrangement. The terms of the transaction and acquisition were discussed in an open meeting.

Is there a motion regarding the Resolution to approve the Lease Purchase Arrangement?"

Alan moved to approve the LPA:

"I move to adopt Resolution No. 002-2022 The Montessori Elementary and Middle School's Governing Council wherein the Council expresses its intent to enter into the Lease Purchase Arrangement with CSDCPC TMS, LLC a Delaware limited liability company on the condition that the LPA is approved by the New Mexico Public Education Department as presented to us by staff and our legal counsel."

Pablo seconded to approve the resolution.

The motion to approve Resolution No. 002-2022 Lease Purchase Agreement for Building & Land at 1730 Montano Rd. NW, Albuquerque, NM 87107 passed 5-0 with a roll call vote.
